# Evidence

If you look at the folder structure, it is not a coincidence where the folder is in relation to the Sinaloa Cartel folder and timestamps from the same day.

This van was there because I had a conversation with someone the prior day on my intruded phone saying I had been targeted with Pegasus while in Mexico.

I knew the Ransomware team was in the midst of a job and this is typical gaslighting (PsyOp) tactics by this cell letting me know the team had me under surveillance and was listening. It is an intimidation tactic and drives the poison the well and general discredit narrative because it sounds fantastic.

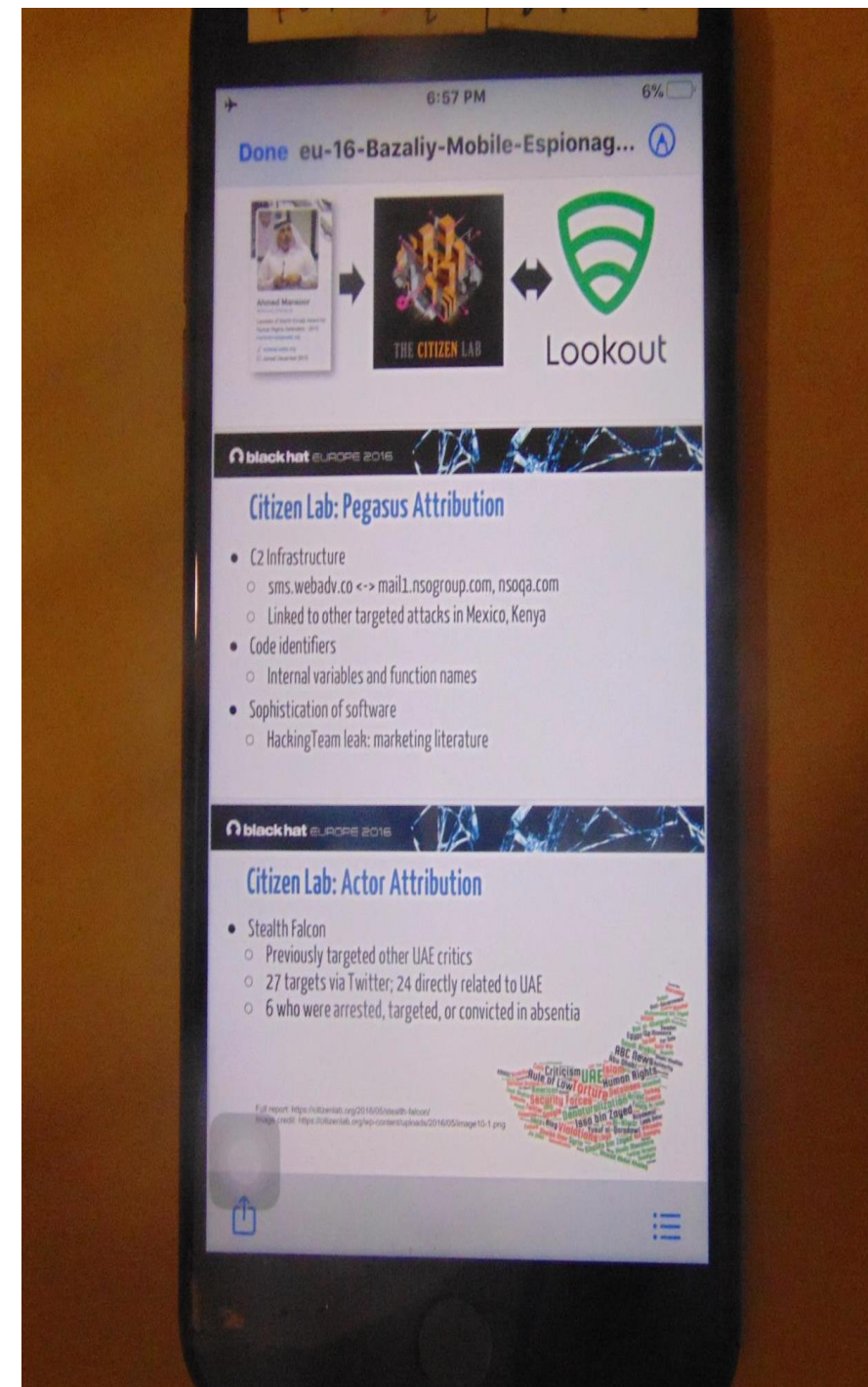


# Pegasus Spyware

This is an image from one of my phones in 2020. I had seen evidence of the Trident infection chain on my government phone while living in Tijuana. Unfortunately no one knew what Pegasus was or that Mexico was the best customer of the NSO from the start. Most people had never heard of Pegasus in early 2020. By way of example, this guardian article did not even publish until a year after my discovery of Pegasus on my phone:

My discovery of Pegasus, in part, is what led me down this rabbit hole. The image to the right is obviously, not evidence of the Trident infection chain. It is only a screenshot to show I was researching Pegasus long ago after being targeted in Mexico. I was a government investigator living in Tijuana, Mexico when targeted. Unfortunately being a nerd surrounded by uninformed and incompetent decision makers and least one corrupt individual in my office was a dangerous dynamic as events have proved.



## Evidence

Specific to Scripps Ransomware Operations, I can identify and provide:

- Some of the ransomware team members
- Solid leads
- Tactics
- License plates relating to suspect vehicles of ransomware team because they are involved in attacking other major entities.
- Interrelationships between criminal organizations operating in the United States and Mexico as well as with other foreigners and show how it involves the Sinaloa Cartel

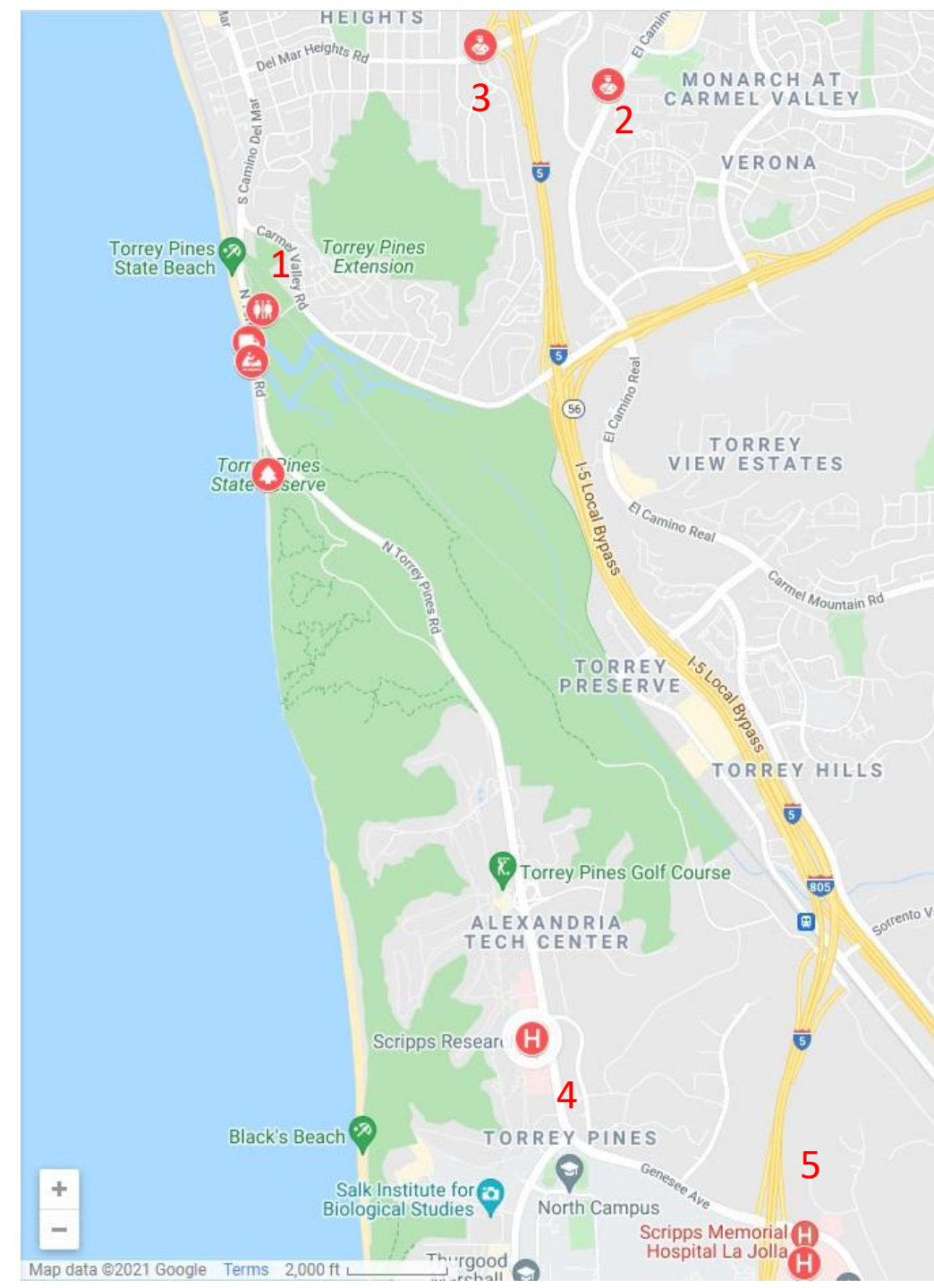
## Location of Criminal Activities: Sinaloa Cartel Trafficking, Corrupt Cops, and Sinaloa backed Cybercrime Operations

Notice how close in proximity the location of Torrey Pines States Beach (1), Scripps Green Hospital (2), the Northwestern San Diego Police Department Division (3), and the laundromat (4) where I was intimidated by corrupt police officers and Scripps Memorial Hospital (5).

Torrey Pine State Beach is near the top left. Below the green icon is where I witnessed the non-interdicted Panga delivery, the cartel counterintelligence team/delivery team the prior week and following the non-interdicted delivery. It was late September or first half of October 2020. CBP Maritime obviously have a record of the panga delivery.

I had been alternating spending a lot of time at Torrey Pines States Beach and Scripps Green Hospital (and law enforcement booth or stations) while I waited for law enforcement assistance (that only came in the form of corrupt local cops and deputies).

The laundromat where I was intimidated out of San Diego by corrupt NW SDPD police officers on approximately October 20, 2020 after being set up for a bogus field contact by corrupt San Diego Police Department officers.

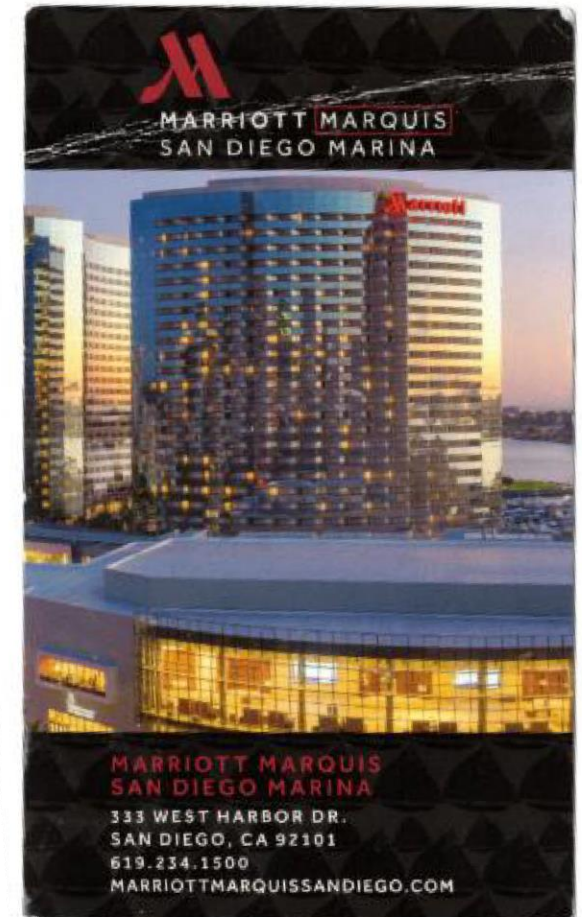

# San Diego International Airport via Dallas Fort Worth International Airport Sunday, August 23, 2020

- I arrive in San Diego to a group of cartel affiliates waiting for me when I deplane and go outside after leaving all those who had been on the plane with me. I leave my phone off because I am going to take it to the FBI so no Uber. I take a regular taxi cab to the Manchester Hyatt to obtain a room via walk-in.
- On the way, the driver, a Latino male mid 50s in appearance, claims he's from Brazil and engages with full hostility. He has a long list of non-sequiturs for me. He said he knew I was a cop (I'm thinking what the fuck) and I'm in a car with that guy driving.
- He said, I know the games you guys play. I was a cop in Rio. I know all about your bullshit in a very angry tone. I never engaged him the entire time. It was evident that he was first in line waiting for me to deplane because his intention was to intimidate me and clearly a cartel lackey. The Sinaloa Cartel leave nothing to chance.



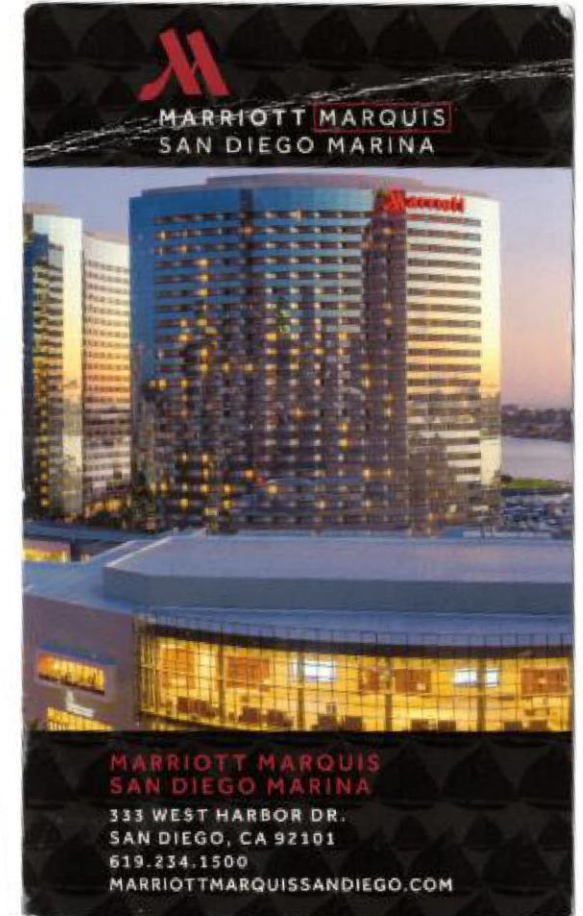
## Marriot Marquis Sunday, August 23, 2020. San Diego, California

- I go to the Marriot Marquis almost next door to the Manchester Hyatt after arriving from DFW. While in line some Black gang bangers pull up. The rooms are about \$250 to \$300 a night at least.
- One hurries over to me and gets in line behind me. Typical tactics. They had been doing this to me the past month: ensuring a black guy was with me wherever I went to intimidate me. They do not say anything one-on-one, they just get in your space to remind you that they are with you and to keep the pressure on.



# Marriot Marquis. San Diego, California Sunday, August 23, 2020

- I linger while this guy talked with front desk to try to get a name which I did: Robert Lewis. He was later 20s, slim build. See enclosed Robert Lewis PDF for possible lead or obtain his information at the desk.
- I looked his name up some months later thinking he is probably from Compton or Nevada where a lot of the gang members were from or claiming with their Bompton, Crenshaw hats and a number of Nevada license plates.
- Sure enough there is a 27 year-old Robert Lewis with Compton and Nevada addresses and living in gang territory. The Robert Lewis has a father in Las Vegas who has felony drug charges. This is a possible multi-generational banger family and is consistent with Los Angeles gang member moving out to Las Vegas and alternating between both locations. Is it the same Robert Lewis? I do not know but it is a good lead since I no longer have access to CLETS. Obtain the hotel registration and you have the guy and may be the match.



# Robert (Eliot) Lewis Compton (Piru territory) I

- By May 2020 I knew I was dealing with at least one Los Angeles street gang.
- August 11, 2020 I was traveling west bound into Texas on the 20, a Range Rover abruptly pulls in front of me where a large group of vehicles that then envelope me. The Range Rover has a fake California license plate that reads PIRU.
- [By the way various other fake plated vehicles with a number of Asians and Whites too (read MITM (man in the middle), MySQL and other related attack team fake plates. These guys do not give have any concerns about law enforcement because they have their game down.
- Piru/Bloods intimidate and chase me across Texas and make a strong showing in DFW area at gun range, DFW Airport, and at the hotel over two different weekends. Informal negotiations fail.

## Robert (Eliot) Lewis Compton (Pirus territory) II

- Robert Lewis, with other gang members waiting outside jumps behind me on August 23, 2020 at Marriot Marquis.
- Pirus originated in Compton so I ran his name in a consumer database and cross referenced with South Central and Las Vegas metro areas. I found a possible suspect since I have no access to CLETS or gang database I cannot confirm.
- The father in Las Vegas has South Central area prior addresses and in Las Vegas. Possible multi-generation banger family as father has cocaine sales charges. And many bangers left Compton area for Las Vegas and other cities when branching out.

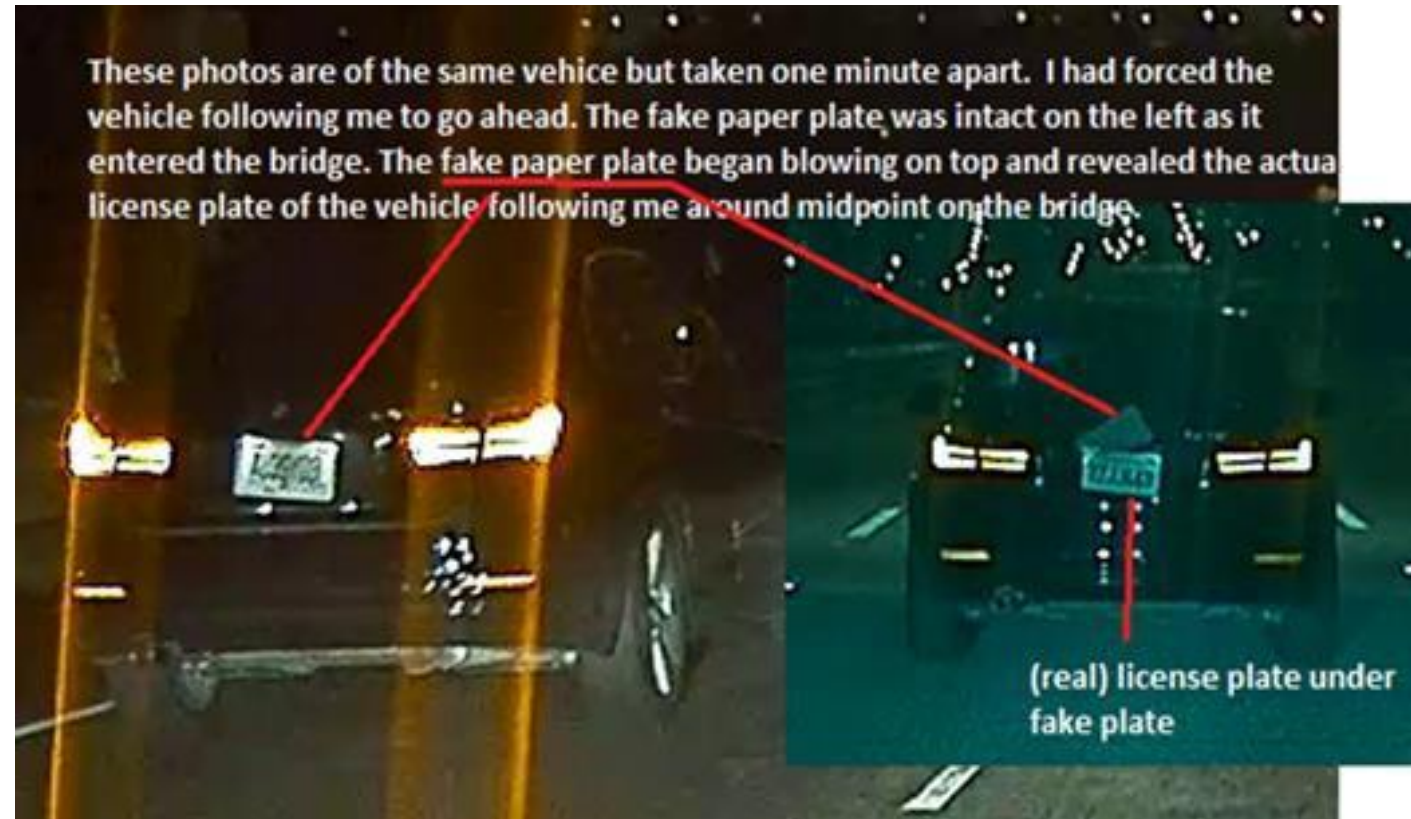

# Intimidation Team Stalking Me Around San Diego County

Sample of dozens of vehicles on me starting in July 2020. Most times their fake license plates do not blow off. This is only one sample of many vehicles I can identify and individuals involved.

Usually I was completely surrounded by attacker vehicles, but in this photos, I was driving a Tesla and the team clearly knows these vehicles have cameras all around so the team backed off i.e. provided some distance. They adapt very quickly. I switched vehicles and the team got right back to keeping me in an “envelope.”

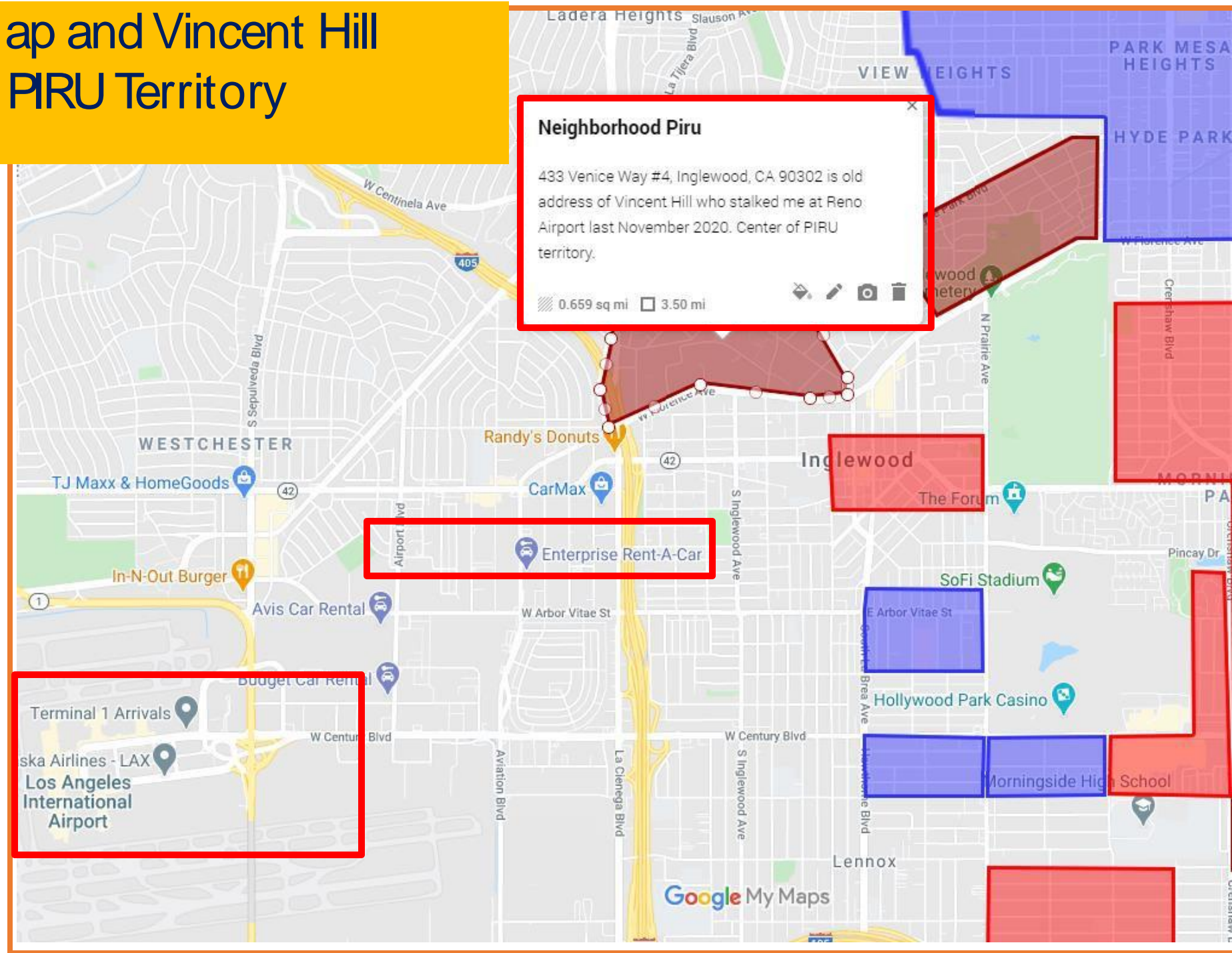

- Another name I pulled because I had to go to Enterprise Rentals at Reno Airport as the Pirus/Bloods had put an operation into play to attempt to get me into law enforcement custody again. I would have been arrested for driving a stolen vehicle if they were successful.
- The Pirus ensured no one answered the San Diego Enterprise phone to prevent me from paying for the rental.
- The Pirus ensured despite being a platinum member on and off for years that I also could not pay for my vehicle via the 1-800 number (more red flags).
- The Pirus had someone at Inglewood Enterprise (LAX Airport) location reserve my vehicle even though my vehicle was picked up at San Diego Enterprise. Whoever reserved my vehicle at Enterprise Inglewood (LAX) is in on the attempt to get the Law Enforcement recall issued.
- The only way to prevent the law enforcement recall which was about to occur was go to an Enterprise location which I did at Reno Airport. The manager at Reno Airport called the transaction very odd and something he had never seen.
- While I am trying to straighten it out, true to expectation and recent experience a black male showed up and sat right next to me and monitored the entire transaction. I figured he was a PIRU. He had a cover as they all do. He was going to drive for Enterprise. It was a fucking charade. I picked up his name. I saw through his bullshit. His name was Vincent Hill or Vinnie Hill. I elicited that he was from Minnesota. There is only one match in the consumer database. I cross-referenced him and saw that he actually had an old address in the heart of Neighborhood PIRU territory in Inglewood California where all the primary Blood set involved in these criminal operations are from.
- One of Vincent Hill's family members has about 80 charges if that says anything.



# Los Angeles Gang Map and Vincent Hill Piru Address in PIRU Territory

- This map shows Piru/Blood. Gang Areas and Crip Areas.
- Note the following landmarks.
- The LAX International Airport
- The LAX Enterprise Rent-A- Car (which is actually in Inglewood) and located adjacent to Neighborhood PIRU territory.
- Vincent Hill whom I have identified as a suspect has a former address in the heart of “Neighborhood Piru territory”



## Ransomware Gang Team Members North San Diego County Lookouts Near House I Went to Stay

This guy is part of the ransomware team. He scrambled behind pole once he saw me approach him. He is posted on a feeder road and near a burrito shop I had been frequenting. They were looking for me on August 9, 2020.

His homie out of frame followed me out to Dallas, Texas on August 12, 2020. Stalked me all around the DFW metro-plex.

He pulled right up next to me when I called the Dallas FBI Field office at which time I was directed back to the San Diego FBI Field office by a duty agent. I also saw the Asian guy's homie downtown across from my old office near the end of September.

He was dude placing the CHP hats in back of a Crown Victoria looking vehicle outside the frame of this photo to the left. My work computers might have photos of him. He's a central player.

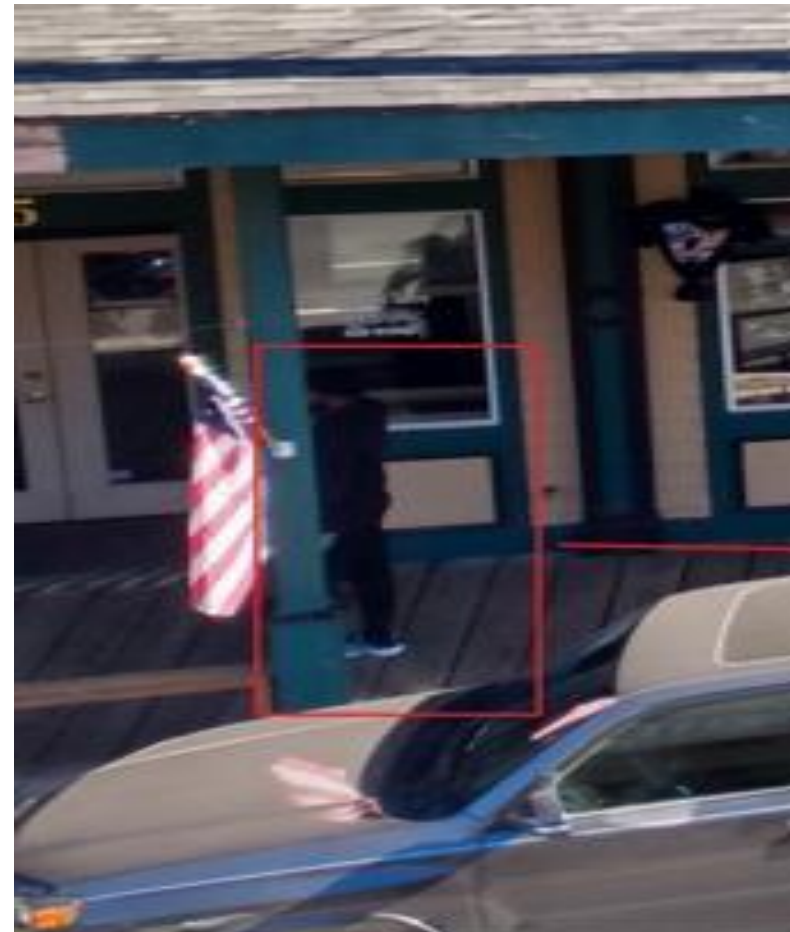
## Team Member Tied to San Diego Cyber Attack Team

These guys are professional, but slip up on occasion. They will jump behind any obstruction in a minute and based on my experience prefer to operate at night, but will do whatever is needed day or night.

They always have cover for plausible deniability and are prepared. It is not a coincidence. This woman with her kids out of frame were his cover and quickly appeared on scene right after I began photographing him. I circled around everyone took off. They have no shame about using children in their operations.

## Photos of “Security Guard” at Scripps Green Around September 2020

Scripps Green photos September 2020 of security guard. I would first determine if he was on contract with Scripps to provide security. Then move from there.

Told me he was a contractor. A guy in an El Camino sat nearby on his computer all night right in front of this guy with the uniform on. It was unusual. Security did nothing. Possible Halcone even if legit contract. TDB. They like to use night security on their jobs.



## San Diego North County Freeway Intimidation and Surveillance. Multiple Vehicles

- ❖ These are stills of video and some actual photos of an example of what the cartel affiliates do on the freeway since the intimidation began. Presumably the homies of the Asian dude on the corner and the guy who was placing the hats standing lookout a few miles away.
- ❖ Other images show the obfuscated plates much better. Like the plate to the left appears to have been altered. The one to the right damaged. They will form a line in front of me blocking me in as a intimidation tactic. This is why the vehicle center is racing ahead of me.
- ❖ They place the target in an envelope. Someone probably has formal training and is instructing these individuals i.e. it is very organized. They communicate on broadcast with each other.
- ❖ They liberally make use of fake paper plates, no license plates, various devices to obfuscate their license plates from gear, trailers, bicycles, racks, dirt, grime, plastic, some font paper plates, lighting to drown it out, mud, plastic hanging out the rear, material or whatever. Probably Asian in center vehicle working with Bloods and Latino male in truck to right. Guy in truck is halcone and assisting with a block and probably that is it.
